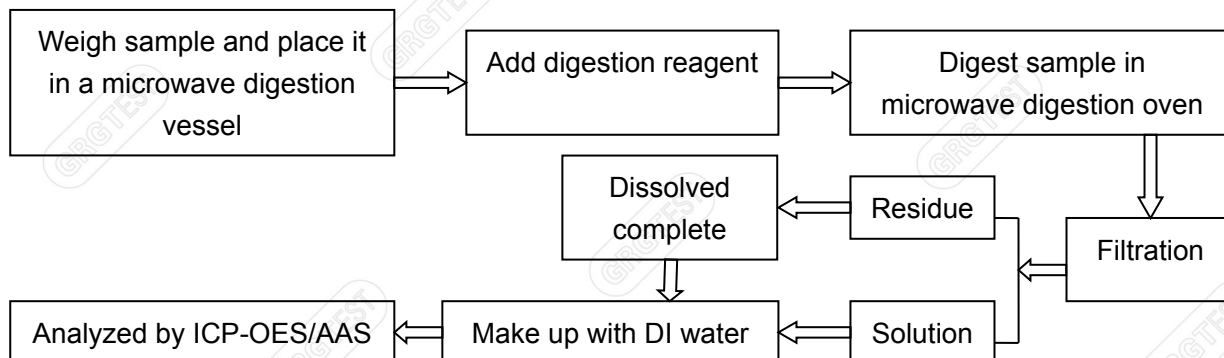

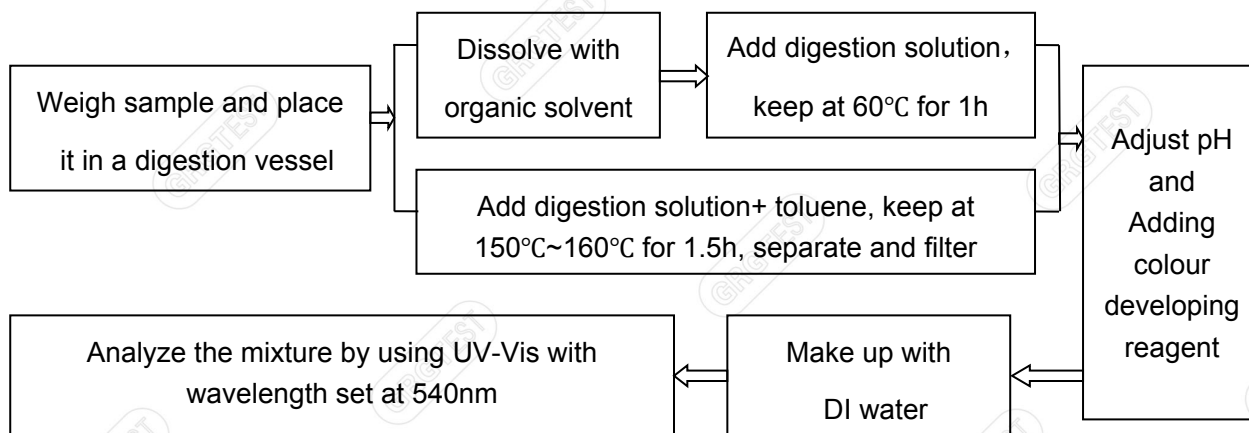

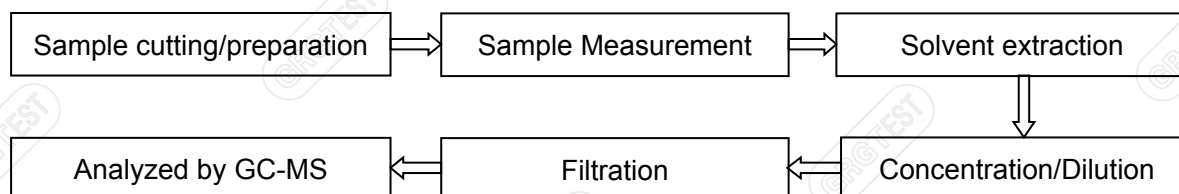
Test Process for Pb / Cd / Hg

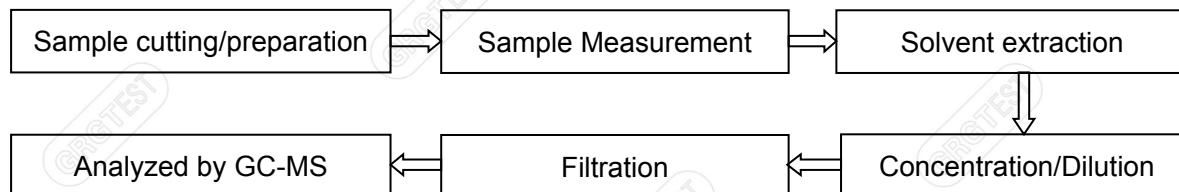
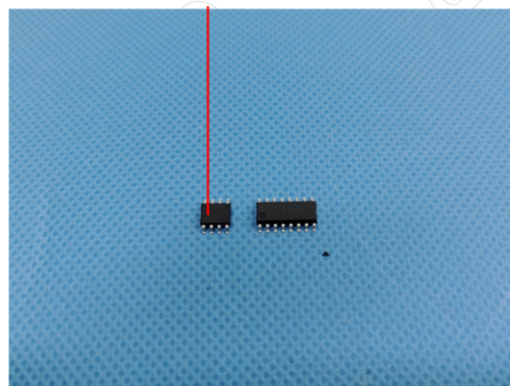
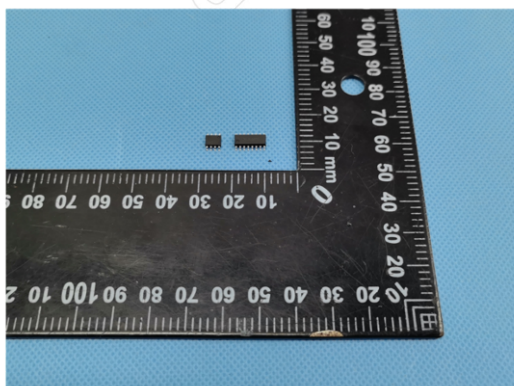


Photo of Sample
